

1. The SwitchaWina, Recharge, Buy a R35 All-In-One bundle and stand a chance to Win a Shoprite/Checkers Voucher (“the **Competition**”) is presented by Cell C Limited (Registration number: 1999/007722/06) and/or its agencies (“**Organizer**”). All persons entering the Competition (“the **Participants**”) agree that the Competition rules as set out in these terms and conditions (“the **Terms and Conditions**”) are binding on them. - 1.1 It is important that participants understand and agree to these Terms and Conditions in order for you to participate in the Competition.
- 1.2 All standard terms and conditions of Cell C Limited and Cell C Service Provider Company Proprietary Limited apply to this Competition.
- 1.3 This Competition is open to all persons who are over the age of 18 years and who are new or existing Cell C prepaid or hybrid customers that recharge and purchase the R35 and All-In-One Bundle.
- 1.4 Directors, members, partners, employees or agents of or consultants to Cell C, or their marketing agencies, or spouses, life partners, parents, children, brothers, sisters, business partners or associates of such persons are not eligible to enter the Competition and cannot win prizes.
- 1.5 The Competition will run from [1 August to 30 September 2020 (“the **Competition Period**”).
- 1.6 You understand that all information (including these Terms and Conditions) relating to this Competition published on any promotional or advertising material or on our website at any time before or during the Competition Period will form part of the Terms and Conditions of entry. Cell C also has the right to withdraw this Competition before the final draw.
2. **Prizes**
- 2.1 The prizes that can be won in this Competition are as follows:
  - 2.1.1 Shoprite/Checkers vouchers for the duration of the Competition Period.
- 2.2 Each prize is valued at R200 (Two Hundred Rand).

2.3 Shoprite/Checkers prize vouchers are valid for a period 12 (twelve) months from date of issue.

2.4 The prize voucher is provided at the sole discretion of the Organizer.

Shoprite/Checkers Vouchers:

- Shoprite/Checkers vouchers relevant terms and conditions will be applicable to all vouchers. This virtual voucher can only be used in-store and cannot be used online.
- The SMS should be kept until the voucher has been redeemed.
- Vouchers can be redeemed only once.
- Vouchers cannot be redeemed at Usave mobile stores, MediRite Pharmacies or at Money Market counters.
- No change will be given if the value of the purchase for which the voucher is used is less than the value of the voucher.
- If the full value of the voucher is not going to be redeemed in one transaction, the remaining value will be loaded onto a gift card in store.
- Vouchers cannot be exchanged for cash.
- Should the voucher be lost or stolen, neither Shoprite & Checkers nor its agents will be liable for any reimbursement of any kind.

To redeem:

- Vouchers are redeemable at any Checkers, Shoprite or Usave store nationwide.

2.5 Please note that no prize may be exchanged for cash. Cell C reserve the right to substitute, change or exchange any prize with another prize of similar commercial value without notice, in their sole discretion. You will not have a claim against Cell C in this event.

### 3. How to enter and awarding of prizes:
