

## **Cell C Home Connecta Fibre Octotel Promotion**

## Last Update: May 2024

- 1. It is important that you understand and agree to these Terms and Conditions in order to participate in the Cell C Home Connecta Fibre Octotel Promotion (the "Promotion").

- 3. The Promotion will run from 1 November 2023 ("Promotion Commencement Date") to 31 December 2024 ("Promotion End Date"). Cell C reserves the right to amend or withdraw the Promotion in its sole and absolute discretion.

- 5. The Promotion applies to new installations only and excludes reconnections, migrations, upgrades, and downgrades. Customers that have signed up for services prior to the Promotion Commencement Date through Cell C do not qualify for the Promotion. For the avoidance of doubt, the promotion is applicable to customers who are new to Cell C Home Connecta Fibre.
- 6. Customers participating in the Promotion shall pay a Promotional Rate for their package for the first full calendar month upon activation, which Promotional Rate can be found in the table under section 9 below.
- 7. In the case where the customer is activated during the month, the customer will be charged a pro-rata amount of the Standard Rate for the activation within the first month, thereafter the customer will pay the Promotion rate and Standard rate will apply and the customer's billing shall be amended to the Standard Rate for their respective package, which Standard Rate can be found in the table under section 9 below.
- 8. Should the customer breach these terms and conditions and / or those set out in the Cell C Fibre Month-to-Month Standard Terms and Conditions, Cell C reserves the right to revoke the Promotion benefits from such customer.
- 9. The Promotion shall only be applicable to customers signing up on one of the following packages. Any Fibre Network Operator and Package Name combination not listed below shall not qualify for the Promotion.
