

## Terms and Conditions of the Cell C Women360 Competition (Sibaya: Durban)

### 1. General

- 1.1 It is important that you understand and agree to these terms and conditions in order for you to participate in this Cell C Women360 Event Competition (the "**Competition**").
- 1.2 All standard terms and conditions of Cell C Limited and Cell C Service Provider Company (Pty) Limited apply to this Competition.
- 1.3 This Competition is organised by Elevator People Marketing Communications (Pty) Limited, registration number 2013//058527//07 ("**Elevator People** and Cell C Limited, registration number 1999/007722/06 ("**Cell C**"). Prizes are sponsored by Cell C South Africa.
- 1.4 The Competition is open to any person over the age of 18, who is in possession of a valid ID book, driver's license or passport. In order to qualify to enter the Competition, you must be present at the Women360 event at Sibaya Hotel in Durban on either Saturday the 24<sup>th</sup> of February 2018 or Sunday the 25<sup>th</sup> of February.
- 1.5 Directors, members, partners, employees or agents of or consultants to Cell C, or their sponsorship agency, or spouses, life partners, parents, children, brothers, sisters, business partners or associates of such persons are not eligible to enter the Competition and cannot win prizes.
- 1.6 The Competition will run from 10h00 on the 24<sup>th</sup> of February 2018 and end at 17h00 on the 25<sup>th</sup> of February 2018. ("**the Competition period**").
- 1.7 You understand that all information (including these terms and conditions) relating to this Competition published on any promotional or advertising material or on our website at any time before or during the incentive period will form part of the terms and conditions of entry. Cell C also has the right to withdraw this Competition before the final draws.

## 2. Prizes

- 2.1 The prizes that can be won in this Competition are as follows:
- 2.1.1 **2 x black smartboxes;**
  - 2.1.2 **2 x Flexi Premium black vouchers; and**
  - 2.1.3 **2 x 100GB Cell C SIM Cards.**
- 2.2 The total value of the prizes amount to R6 394.00 (six thousand three hundred and ninety four rand) only.
- 2.3 The Prizes will be awarded as follows:
- 2.3.1 One (1) x black smartbox with one (1) Flexi Premium black voucher and one (1) 100GB Cell C SIM card to be won on Saturday the 24<sup>th</sup> of February, and
  - 2.3.2 One (1) x black smartbox with one (1) Flexi Premium black voucher and one (1) 100GB Cell C SIM card to be won on Sunday the 25<sup>th</sup> of February.
- 2.4 You understand that no prize may be exchanged for cash. Cell C and/or Elevator People reserve the right to substitute, change or exchange any prize with another prize of similar commercial value without notice, in their sole discretion. You will not have a claim against Cell C or Elevator People in this event.
- 2.5 It is important that you understand that all participants (and winners) of the Competition indemnify Cell C and Elevator People, its directors, affiliates, members, partners, employees, agents, consultants, suppliers, contractors and sponsors against any loss or damages, either direct, indirect, consequential or otherwise, arising from its participation in this Competition.
- 2.6 The prizes as advertised in any point of sale or electronic marketing communication are merely for illustrative purposes and may differ at the time of prize giving. Every effort will be made to ensure that the model is of a similar feature and based on availability at the time of dispatch from the manufacturer, but this cannot be guaranteed.

### **3. How to enter and awarding of prizes:**

- 3.1 To participate in this Competition, you must:
  - 3.1.1 Comply with the requirements as set out in paragraph 1.4 above ;
  - 3.1.2 Have your photo taken at the Cell C stand at the Women360 experiential event which will be held at the Sibaya Hotel in Durban on the 24<sup>th</sup> and 25<sup>th</sup> of February 2018; and
  - 3.1.3 Once you have taken your photo, you must upload your photo to your Instagram account and beat the 45 second timer to hash tag the line “Cell C’s C-Fibre. The best way to connect to the future of entertainment. Now”.
  - 3.1.4 If you manage to upload your photo to Instagram within the 45 seconds with the correct hash tag line, you will be put forward for the random draw. The winner will be chosen via the random draw.
- 3.2 Cell C and/or Elevator People have the right at any time before the final draw to change the dates or places of the draws (or both). You will not have a claim against Cell C or Elevator People in this event.
- 3.3 Any prize that is not claimed for whatever reason will be forfeited.

### **4. If you are a winner:**

- 4.1 The winner of the competition will be notified on the day. The announcement will take place over loudspeaker and the selected winner will then be telephonically notified as well. The winner will need to be present at the time of draw and will forfeit his/her prize should they not be present to claim their prize.

You agree that should you not be present and Cell C/Elevator People be unable to contact you, you will forfeit the prize, and shall have no claim against Cell C/Elevator People in this event.
