

Terms and Conditions of the Cell C MegaBonus Radio Competition

1. General

- 1.1 It is important that you understand and agree to these terms and conditions in order for you to participate in this MegaBonus Radio Competition (the "Competition").
- 1.2 All standard terms and conditions of Cell C (Pty) Limited and Cell C Service Provider Company (Pty) Limited apply to this Competition.
- 1.3 This Competition is organised by Cell C (Pty) Limited, registration number 1999/007722/07 ("**Cell C**"). Prizes are sponsored by Cell C.
- 1.4 This Competition is open to all persons who are over the age of 18 years and who answer the questions correctly.
- 1.5 Directors, members, partners, employees or agents of or consultants to Cell C, or their sponsorship agency, or spouses, life partners, parents, children, brothers, sisters, business partners or associates of such persons are not eligible to enter the Competition and cannot win prizes.
- 1.6 The Competition will run from the 6th June – 24th June 2016 ("**the Competition period**").
- 1.7 You understand that all information (including these terms and conditions) relating to this Competition published on any promotional or advertising material or on our website at any time before or during the incentive period will form part of the terms and conditions of entry. Cell C also has the right to withdraw this Competition before the final draw.

2. Prizes

- 2.1 The prizes that can be won in this Competition are as follows:

- 2.1.1 **First question** answered correctly: **R1000 (one thousand Rand) on a cash card. Second question** answered correctly: **R1000 (one thousand Rand) on a cash card. Third question** answered correctly, the prize will be tripled to **R6000 (six thousand Rand) available on a cash card.**
- 2.1.2 If the first question is answered incorrectly, the caller can no longer proceed in the Competition and will win no prize. If the caller answers the first question correctly, but the second question incorrectly, they will receive only R1000 (one thousand Rand) on a cash card and no longer be able to proceed in the Competition. If the caller answers the first two questions correctly but the last question incorrectly, they will receive only R2000 (two thousand Rand) on the cash card from the prior two correctly answered questions. If they answer all three questions correctly, they will receive the full R6000 (six thousand Rand) on a cash card.

- 2.1.4 The total value of the prizes over the Competition Period amounts to R240 000.00 (two hundred and forty thousand Rand).
- 2.2 You understand that no prize may be exchanged for cash. Cell C reserve the right to substitute, change or exchange any prize with another prize of similar commercial value without notice, in their sole discretion. You will not have a claim against Cell in this event.
- 2.3 It is important that you understand that all participants (and winners) of the Competition indemnify Cell C, its directors, affiliates, members, partners, employees, agents, consultants, suppliers, contractors and sponsors against

any loss or damages, either direct, indirect, consequential or otherwise, arising from its participation in this Competition.

3. How to enter and awarding of prizes:

- 3.2 Once you have met all the conditions set out in paragraph 3.1 above, you may enter the Competition.

- 3.2.1 The prizes will be drawn daily, during the relevant times on each radio show. The winner will be announced immediately during the live broadcast and the radio station will get the winners details to send the cash card prize to them.

- 3.3 Cell C and/or have the right at any time before the final draw to change the dates or places of the draws (or both). You will not have a claim against Cell C in this event.

- 3.4 Any prize that is not claimed for whatever reason will be forfeited.

4. If you are a winner:
