

## **Terms and Conditions of the Black Promotion**

### **1. General**

- 1.1. All standard terms and conditions of Cell C Limited and Cell C Service Provider Company (Pty) Limited apply.
- 1.2. All prices shown include VAT.
- 1.3. Cell C may amend, modify or otherwise change these terms and conditions in its sole and absolute discretion on notice to you and the amended version will be displayed in the same media as these terms and conditions.
- 1.4. If a customer does not comply with these terms and conditions and/or the processes applicable, Cell C reserves the right to refuse the customer from signing up for the Promotion.
- 1.5. Cell C reserves the right to suspend and/or withdraw the Promotion and the promotional data in its sole discretion, including when any fraudulent activity is suspected.
- 1.6. Cell C has the right to withdraw, or shorten the duration of the Promotion and/or change the promotional data value in its sole and absolute discretion and will notify customers if it chooses to do so. Customers will not have a claim against Cell C in this event.
- 1.7. Cell C and any of its agents, directors, affiliates, members or employees shall not be responsible in any way for claims, loss or damages (either direct, indirect, consequential or otherwise), arising from customers' participation in the Promotion.

### **2. Black Recharge Promotion 1 – Prepaid**

- 2.1. Cell C will be launching a new black Recharge Promotion 1 ("Promotion") valid 24 November 2017 to 31 December 2017.
- 2.2. Customers need to subscribe to black to use the black platform and partake in the promotion.
- 2.3. Prepaid customers who recharge from R50 to R99.99, in a single recharge, qualify for promotional data for streaming a rented or purchased black movie off the black platform.
- 2.4. The promotional data will be valid for 2 days (48 hours) from time of recharge and thereafter will expire.
- 2.5. Rental and/or purchase of the movie will be for the customer's own account. The promotional data is only applicable for the downloading and/or streaming of the movie.
- 2.6. The promotional data is on-net only (No national roaming will be allowed).
- 2.7. A Fair Usage Policy (FUP) of 50GB applies for the promotional data.

- 2.8. The recharge amount in order to qualify for the promotion must be a single recharge between R50 to R99.99.
- 2.9. Multiple recharges in terms of the recharge promotion will be allowed.
- 2.10. The promotion applies to the following Prepaid plans: Cell C EasyChat, 66c, MegaBonus & SupaCharge.
- 2.11. Customers will still qualify for the recharge reward bonus (SupaCharge etc.)
- 2.12. The promotion will apply to the qualifying MSISDN and may not be transferred.

### **3. Black Recharge Promotion 2 – Prepaid**

- 3.1. Cell C will be launching a new black Recharge Promotion 1 (“Promotion”) valid 24 November 2017 to 31 December 2017.
- 3.2. Customers need to subscribe to black to use the black platform and partake in the promotion.
- 3.3. Prepaid customers who recharge for R100 and above, in a single recharge, qualify for promotional data for streaming a rented or purchased black movie off the black platform.
- 3.4. The promotional data will be valid for 5 days (120 hours) from time of recharge, and thereafter will expire.
- 3.5. Rental and/or purchase of the movie will be for the customer’s own account. The promotional data is only applicable for the downloading and/or streaming of the movie.
- 3.6. The promotional data is on-net only (No national roaming will be allowed).
- 3.7. A Fair Usage Policy (FUP) of 100GB applies for the promotional data.
- 3.8. The recharge amount in order to qualify for the promotion must be a single recharge of R100 and or above.
- 3.9. Multiple recharges in terms of the recharge promotion will be allowed.
- 3.10. The promotion applies to the following Prepaid plans: Cell C EasyChat, 66c, MegaBonus & SupaCharge.
- 3.11. Customers will still qualify for the recharge reward bonus (SupaCharge etc.)
- 3.12. The promotion will apply to the qualifying MSISDN and may not be transferred.

### **4. Black Contract Promotion 3 - Postpaid/TopUp**

- 4.1. Cell C will be launching a new black promotion valid 24 November 2017 to 31 December 2017.
- 4.2. Customers need to subscribe to black to use the black platform and partake in the promotion.
- 4.3. All new and existing Connector (Postpaid), and Pinnacle 100 and above (Postpaid & TopUp) customers, will qualify for promotional data for streaming a rented or purchased black movie off the black platform.
- 4.4. The promotional data will be allocated in November and in December only.
  - 4.4.1. Existing customers will receive the full allocation in November and December.
  - 4.4.2. New customers will receive a pro-rated allocation in November and the full allocation December.
- 4.5. The promotional data will be valid for the month of allocation only. There will be no carryover.
- 4.6. Rental and/or purchase of the movie will be for the customer's own account. The promotional data is only applicable for the downloading and/or streaming of the movie.
- 4.7. The promotional data is on-net only (No national roaming will be allowed).
- 4.8. A Fair Usage Policy (FUP) of 150GB applies for the promotional data.
- 4.9. The promotion will apply to the qualifying MSISDN and may not be transferred.
- 4.10. Pinnacle 30 (Postpaid & TopUp) and 50 (Postpaid & TopUp) plans are excluded from the promotion.
